## Northside Stormwater Management Plan

Mayor Kernc welcomed Tim Henjy to the meeting. Henjy presented alternatives for stormwater for properties north of IL Route 113. The detention proposed would meet current codes required. The conceptual plans could assist in finding grant funding for the project. Question and answers of the conceptual plan took place. Mayor Kernc stated by doing this study, it is the first step required for the funding of such a project. This is just conceptual currently. Kernc thanked Henjy for his work in this plan.

#### 2021 Tax Levy Discussion

Village Attorney John Gallo presented the board with historical data, tax rate comparisons of surrounding villages and option for the 2021 tax year. After brief discussion, the board would like to move forward with option A which was presented by Gallo which would be a tax rate of .5073%, a decrease from last year. Gallo will move forward to prepare ordinance and filing paperwork. This will be an agenda item on the December 14, 2021, meeting.

## Approve Resolution #2021-05, Adopting a Qualification-Based Selection Policy

Mayor Kernc stated the village is approved for \$340,000.00 for STP3 Phase II Engineering. The Village must advertise and accept proposals from consultants for all engineering and professional services interested in this project. **MOTION** was made by Commissioner Adair, **SECOND** by Commissioner Kasher to Approve Resolution #2021-05, Adopting a Qualification-Based Selection Policy. **All Ayes: Motion Carried.** 

## Grundy Regional Transportation Plan

Mayor Kernc stated Grundy County Economic Development held a meeting the other day with the mayors from within the county. Will County has been very successful with their transportation plan and funding within their county. A Grundy Regional Transportation Plan would determine the transportation priorities for Grundy County and could also improve the chances of successful grant applications.

Approve Ordinance #2021-17, Grundy County Animal Control Intergovernmental Agreement

Village Attorney John Gallo stated the ordinance is required for the #2021-22 Intergovernmental Agreement with Grundy County Animal Control. **MOTION** was made by Commissioner Kasher, **SECOND** by Commissioner Warner to Approve Ordinance #2021-17, Grundy County Animal Control Intergovernmental Agreement. **All Ayes: Motion Carried.**

Kernc had Village Attorney John Gallo look over proposed documents from NonprofitWater.org.
